RELEASE AND WAIVER OF LIABILITY AGREEMENT

IN CONSIDERATION for being permitted to participate in the activities of the Palo Alto Foothills Tracking Association, Inc. (hereinafter "PAFTA"), the undersigned, for himself/herself and for all personal representatives, heirs, assigns, and next of kin:

1. HEREBY ACKNOWLEDGES THAT PARTICIPATION IN PAFTA ACTIVITIES MAY BE DANGEROUS and involves the risk of bodily injury, property damage and/or death;
2. HEREBY RELEASES, WAIVES, INDEMNIFIES, DISCHARGES AND COVENANTS NOT TO SUE PAFTA and/or any of its members, employees, directors, officers, owners, agents, promoters, operators, contractors, representatives, and/or other participants (hereinafter "releasees") for any loss and/or damage, and any claim(s) and/or demand(s) therefore, on account of i) any injury to my person, dog(s), and/or other property; and/or ii) any events resulting in my death and/or my dog(s) death, arising out of or in any way related to PAFTA activities, whether caused by the negligence of the releasees or otherwise;
3. HEREBY EXPRESSLY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, PROPERTY DAMAGE, OR DEATH of myself and/or my dog(s), arising out of or related to PAFTA activities, whether caused by the negligence of the releasees or otherwise;
4. HEREBY EXPRESSLY ASSUMES FULL RESPONSIBILITY FOR ANY BODILY INJURY, PROPERTY DAMAGE, OR DEATH, including any financial responsibility for any possible litigation and/or any other dispute arising from any incident in which I may be involved. I assume all financial liability and will also assume all and any financial costs associated with my actions and/or those of my dog(s) that results in bodily injury, property damage and/or death; and
5. HEREBY ACKNOWLEDGES THAT THE PAFTA ACTIVITIES REFERRED TO IN THIS AGREEMENT include all PAFTA functions and activities without restriction of any kind, including, but not limited to, tracking, dog obedience classes, trials, tracking tests, workshops, clinics, and meetings, as well as setting up and taking down facilities, equipment, etc., for the foregoing activities, and travel to and from such activities.

A LEGAL GUARDIAN SIGNING BELOW ON BEHALF OF A MINOR CHILD AGREES TO DEFEND, INDEMNIFY AND HOLD HARMLESS the releasees from any claim for injury or damage to such child and/or the legal guardian, as well as any dog(s) owned/trained/handled by the child and/or legal guardian.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
