

JUDGING PROGRAM INFORMATION

All dogs and handlers must be at the Rangers Station, Anderson Lake/Coyote Creek Parkway, Morgan Hill, CA by 8:00 a.m. Sunday, January 6, 2019, at which time there will be a drawing to determine the running order. Entrants not present at the time of the drawing will be marked absent. Judging will begin when the tracks are sufficiently aged.

Bitches in season may participate in this test with prior notice to the Test Secretary and provided that all provisions of Chapter 2, Section 8 of the AKC Tracking Regulations are complied with.

We remind you that ticks are endemic in this area, and you are advised to take precautions to protect yourself and your dog. We also suggest that you bring a chair for yourself and shade for your dog in the event that it is a bright sunny day.

At the conclusion of the test, all participants and spectators are invited to stay for presentation of awards to passing dogs.

We look forward to a very successful certification event for all entrants and wish you the best of luck. Remember to have fun!

Directions to the Ranger Station at Anderson Lake/Coyote Creek Parkway, 19245 Malaguerra Avenue, Morgan Hill, CA 95037: From 101 North or South, exit at Cochrane Road. Go East on Cochrane to Malaguerra Avenue (about 1 mile). Turn Left on Malaguerra Avenue and follow it for 0.4 mile. There is parking adjacent to the Ranger Station. Parking is free and there is a covered area with rest rooms by the ranger station where we will have the draw for the tracks.
