**CLOSING DATE FOR ENTRIES:** Entries will be accepted until Thursday, March 3, 2022, at 6:00 p.m., after which time entries will not be accepted, cancelled, altered, or substituted.

**ENTRY FEE:** TD - \$60.00, TDX - \$125.00. A \$.50 recording fee plus \$3.00 AKC Event Service Fee are included in each entry and will be forwarded to the AKC per Chapter 11, Section 2 of the AKC Rules. Make checks payable to **PAFTA**.

**MAIL ENTRIES WITH FEES TO:** Karey Krauter, Test Secretary, 374 Stanford Avenue, Palo Alto, CA 94306.

**ELIGIBILITY:** TD entries limited to 2 dogs with appropriate Certification or that have previously passed an AKC Tracking Test. TDX entry is limited to 1 dog that has previously passed an AKC Tracking Test. Test Secretary will give priority to dogs who do not already hold the title for the test level entered. Entries are limited to AKC-recognized pure breed dogs.

**EXCHANGE of TRACKS:** If the limit for entries is not reached in either the TD or TDX test and the other is exceeded, the number of tracks offered may be exchanged on the basis of two (2) TD tracks for one (1) TDX track.

**BITCHES IN SEASON:** Bitches in season may participate in this test with prior notice to the Test Secretary and provided that all provisions of Chapter 2, Section 8 of the AKC Tracking Regulations are complied with.

**DRAWING:** A random drawing of entries received by the closing date and time will be held on Thursday, March 3, 2022, at 6:15 p.m. at Starbucks, 2000 El Camino Real, Palo Alto CA 94306, phone 650-320-8125.

**ALTERNATE LIST:** An alternate list shall be maintained and will consist of entries received by the closing date, but not pulled in the initial draw. Drawing for the alternate list will immediately follow the drawing for the limited entries.

**CERTIFICATION:** Each entry of a dog that has not passed an AKC Tracking Test must include an original, signed certification dated within 24 months of the test by an approved or provisional AKC Tracking Judge or an Evaluator (any person who has titled a TDX or VST dog within the past ten (10) years.)

**NOTIFICATION:** The results of the draw will be sent as soon as possible following the draw. Should such notification not be received by the exhibitor within a reasonable time, please notify the Test Secretary.

**PAFTA REFUND POLICY:** The entry fee shall be refunded within seven (7) days after the test in the following cases: 1) The entrant notifies the Test Secretary prior to the Test that they are withdrawing from the test, and an alternate runs the track, or 2) For an entrant or alternate that is not given an opportunity to run a track.

**DRAWING FOR RUNNING ORDER:** All dogs and handlers must be at the test area by the designated times shown below on Sunday, March 13, 2022, at which time there will be a draw to determine the running order. Entrants not present at the time of their draw will be marked absent and an alternate will be allowed to run in their place. TD – 8:00 a.m., TDX – 10:00 a.m..

**JUDGING:** Judging will begin as soon as the tracks have aged sufficiently.

**AWARDS:** An award will be offered for each dog passing the test.

**HEALTH AND SAFETY:** The health and safety of the dogs, exhibitors, judges, and spectators is of paramount importance. The test may be cancelled or stopped before completion in the case of extreme weather conditions such as, but not limited to, lightning, extreme heat, hurricanes, floods, or earthquakes, for the well-being of people and dogs. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccine is required in the State of California.

**DIRECTIONS:** 101 North or South - exit at Cochrane Road. Go East on Cochrane to Malaguerra Avenue (about 1 mile). Left onto Malaguerra Avenue and follow for 0.4 mile. The road bears to the left into the Park parking lot. Parking is free and there is a covered area and rest rooms by the ranger station.

**PRACTICING:** Practicing on the test sites is not allowed except by ID-carrying members of clubs which have obtained a use permit. Dogs **MUST** be kept on leash at **ALL** times. Your cooperation in adhering to the regulations will be greatly appreciated. Handlers are expected to clean up after their dogs immediately.

**NOTE:** You are advised to bring tick spray for your dog and yourself as ticks are present in the area.

**COVID-19 Best Practices:** Our goal is to keep everyone as safe as we can. If any exhibitor is sick, know they have been exposed to COVID-19 or uncomfortable with the precautions PAFTA is taking, **do not enter**, and stay home. Our mental and physical well-being is most important at all times. Remember when entering a tracking test, it is done at your own risk. If you have not read the Agreement in your trial entry, you should do so now and be aware of what you are signing.

We will be following the rules and guidelines set forward by our state, county, and local agencies along with CDC and AKC guidelines. Our aim is to keep our judges, volunteers, and exhibitors as safe as possible.

If you have traveled out of the state in the last 14 days, consider staying home. If you have a cough, sore throat, shortness of breath or problems breathing, fever/chills, muscle pain or a loss of taste or smell, STAY HOME! If you have recently been in the presence of a person who has either tested positive for COVID-19 or has symptoms listed above, STAY HOME.

- ❖ Wear facial masks when in close proximity to others and /or when required by the club (**bring your own mask**). Masks will be worn over the nose and mouth at all times. Facial netting and masks with vents or valves are **NOT** acceptable facial covering or masks.
- ❖ Wash hands as frequently as possible. **Bring your own hand sanitizer.**
- ❖ Leave at least a vehicle or two spaces between your vehicles. There is plenty of parking.
- ❖ Practice social distancing consistent with current guidelines.
- ❖ Avoid congregating to the extent possible.
- ❖ Avoid shaking hands or hugging.
- ❖ Avoid touching dogs that are not yours, as the owner may have kissed their dog.
- ❖ Avoid common use of pens/pencils – bring your own.
- ❖ The gallery should practice social distancing guidelines.

**Tracklayers WILL be handling/scenting the articles. If you are uncomfortable handling the articles, please wear disposable/washable gloves (bring your own gloves).**

### **IMPORTANT 10 Day Rules**

1. No exhibitor may show a dog under a judge at a tracking test if the exhibitor has participated in a training session taught by that judge within thirty (10) days prior to the date of the event.

2. People cannot act as tracklayers for dogs if, within the past 10 days, they have boarded, laid a track for, or regularly trained the dogs whose tracks they are to lay. The tracklayer must not be a person with whom the dog has resided or a member of the household or a member of the immediate family of the dog's handler. The judges will determine the order in which the tracks are run and the number of each track. The judges may modify the draw to meet the requirements of the tracklayer.

- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed.
