So, assuming that we've pre-plotted at least two tracks at Evergreen, we could meet at 9:00 am there on Saturday and walk the tracklayers through their respective tracks--- maybe 30 minutes per track. Then we can go on to West Valley and plot the remaining tracks there--- I checked out West Valley a month ago and believe that the campus can accommodate two tracks.

I think 9:00 am on Saturday would work well, unless we hear differently from Kamrin.
