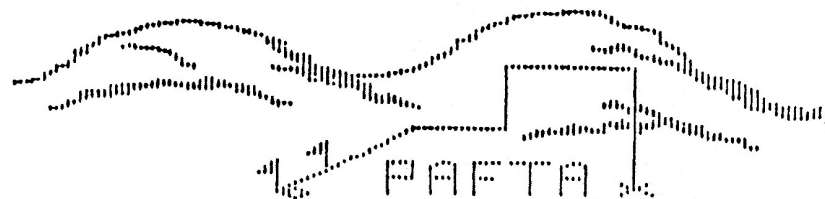

**CLOSING DATE FOR ENTRIES:** Entries will be accepted until Thursday, February 26, 2026, at 6:00 p.m., after which time entries will not be accepted, cancelled, altered, or substituted.

**ENTRY FEE:** \$75.00. A \$.50 recording fee plus \$4.00 AKC Event Service Fee are included in each entry and will be forwarded to the AKC per Chapter 11, Section 2 of the AKC Rules. Make checks payable to **PAFTA**.

**MAIL ENTRIES WITH FEES TO:** Karey Krauter, Test Secretary, 374 Stanford Ave, Palo Alto, CA 94306. Overnight and express mail entries **MUST** specify NO SIGNATURE REQUIRED.

**ELIGIBILITY:** Dogs that have earned a TD, TDU, TDX, or VST shall not be barred from participation in this test; however, the Test Secretary shall give priority to entries for dogs that do not hold any tracking title. Entries are limited to 3 dogs.

**BITCHES IN SEASON:** Bitches in season may participate in this test with prior notice to the Test Secretary and provided that all provisions of Chapter 2, Section 8 of the AKC Tracking Regulations are complied with.

**DRAWING:** A random drawing of entries received by the closing date and time will be held on Thursday, February 26, 2026, at 6:15 p.m. at Starbucks Coffee, 2000 El Camino Real, Palo Alto CA 94306, phone 650-320-8125.

**ALTERNATE LIST:** An alternate list shall be maintained and will consist of entries received by the closing date, but not pulled in the initial draw. Drawing for the alternate list will immediately follow the drawing for the limited entries.

**CERTIFICATION:** A written statement must accompany each entry for any dog that has not previously passed an AKC TD or TDU test. This statement must be dated within two years of the test date, signed by either a person approved to judge tracking tests, or by a person/evaluator who has handled a dog to a TDX or VST title within the last ten (10) years, and must certify that the dog has satisfactorily performed a certification test.

**NOTIFICATION:** The results of the draw will be sent as soon as possible following the draw. Should such notification not be received by the exhibitor within a reasonable time, please notify the Test Secretary.

**PAFTA REFUND POLICY:** The entry fee shall be refunded within seven (7) days after the test in the following cases: 1) The entrant notifies the Test Secretary prior to the Test that they are withdrawing from the test, and an alternate runs the track, or 2) For an entrant or alternate that is not given an opportunity to run a track.

**DRAWING FOR RUNNING ORDER:** All dogs and handlers must be at the test area by 8:00 a.m. Sunday, March 8, 2026, at which time there will be a drawing to determine running order. Entrants not present at the time of the drawing will be marked absent and an alternate will be allowed to run in their place.

**JUDGING:** Judging will begin as soon as the tracks have aged sufficiently.

**AWARDS:** An award will be offered for each dog passing the test.

**DIRECTIONS:** 101 North or South - exit at Cochrane Road. Go East on Cochrane to Malaguerra Avenue (about 1 mile). Left onto Malaguerra Avenue and follow for 0.4 mile. The road bears to the left into the Park parking lot. Parking is free and there is a covered area and rest rooms by the ranger station.

**PRACTICING:** Practicing on the test sites is not allowed except by ID-carrying members of clubs which have obtained a use permit. Dogs **MUST** be kept on leash at **ALL** times. Your cooperation in adhering to the regulations will be greatly appreciated. Handlers are expected to clean up after their dogs immediately.

**NOTE:** You are advised to bring tick spray for your dog and yourself as ticks are present in the area.

**HEALTH AND SAFETY:** The health and safety of the dogs, exhibitors, judges, and spectators is of paramount importance. The test may be cancelled or stopped before completion in the case of extreme weather conditions such as, but not limited to, lightning, extreme heat, hurricanes, floods, or earthquakes, for the well-being of people and dogs. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccine is required in the State of California.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, howsoever such injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. **I (we) agree that any cause of action, controversy or claim arising out of or related to the entry, exhibition or attendance at the event between the AKC and the event-giving club (unless otherwise stated in its premium list) and myself (ourselves) or as to the construction, interpretation and effect of this agreement shall be settled by arbitration pursuant to the applicable rules of the American Arbitration Association. However, prior to arbitration, all applicable AKC bylaws, rules, regulations and procedures must first be followed as set forth in the AKC Charter and Bylaws, Rules, Regulations, Published Policies, and Guidelines.**

(Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety you are entering i.e., Cocker Spaniel (solid color black, ASCOB, parti-color); Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.); Dachshunds (longhaired, smooth, wirehaired); Bull Terriers (colored, white); Manchester Terriers (standard, toy); Chihuahuas (smooth coat, long coat); English Toy Spaniels (King Charles & Ruby, Blenheim and Prince Charles); Poodles (toy, miniature, standard); Collies (rough, smooth).

A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
